## 8. IMPORTANT INFORMATION FOR APPLICANTS

a. Change of Name

If you have changed your name or if any of your documents show a name which is different from this application form, then you must present certified documentary evidence of the change.

b. International Student Registration Fees

All international students registering with and receiving an offer from the Singapore Campus are required to pay International Student Registration Fees of S\$500.00 (incl. of GST). The fees cover a range of services provided to international students by JCU Singapore and is payable at the time the student accepts an offer of a place at the university.

c. Regulation of Student Pass

International students holding a Student Pass issued by the Singapore Immigration and Checkpoints Authority (ICA) are strictly forbidden to engage in any form of employment during the validity of their student pass.

d. Case Trust Student Tuition Fee Insurance

In compliance with Case Trust for Education, international students who have accepted a place to study at JCU Singapore will be required to pay Tuition Fee Insurance. This insurance serves to protect the students' fees in the event that JCU Singapore is unable to continue operations. Furthermore, the SPS protects the student if the school fails to pay penalties or return fees to the student arising from judgments made against it by the Singapore courts. This is also a personal protection scheme that entitles you up to SGD\$10,000 coverage upon death or total permanent disability.

e. Accident and Hospitalisation Insurance

All international students in Singapore are covered under a group personal accident policy, as well as a group hospitalisation policy. Insurance premiums are payable annually. Please contact Student Service for more details on the premiums and coverage.
