The Singapore campus of James Cook University is fully owned by James Cook University Australia, which is ranked in the top 2% of universities in the world<sup>1</sup>. James Cook University Australia established its Singapore campus in 2003 as part of its expressed intent of internationalising its activities and offers a suite of university level programs at the Singapore campus covering the areas of Business, Information Technology, Psychology, Guidance and Counselling, Science, Commerce, Accounting, Aquaculture, Environmental Science, Games Design, Tourism and Hospitality.

James Cook University offers Higher Degree by Research programs such as Doctor of Philosophy, Master of Philosophy and pathways to a higher degree.

Additionally, the campus offers courses at the pre-university level, specifically designed to provide pathways for students who are unable to immediately meet university entrance standards.

The Singapore campus of James Cook University is located at Sims Drive. The campus provides students with access to a full range of facilities and services to support their learning. These include lecture and seminar rooms, library and associated study facilities, computer laboratories, aquaculture research and teaching facility, financial lab and access to a variety of sporting facilities.

## James Cook University Inter-campus Exchange Program\*

# Master of Guidance and Counselling

Human, personal, educational, and employment needs are becoming ever more complex in the 21st century context of continuing and rapid change. Counselling professionals provide an invaluable service by helping people grow and thrive in such an environment.

Our Master of Guidance and Counselling (MGC) course provides advanced academic and practical training in the professional discipline of counselling. It is designed to meet the developmental needs of individuals wishing to enter the counselling profession, as well as individuals seeking to develop important human and interpersonal skills in other professions.

The course has the advantage of being formally recognised as an initial counsellor training course by the Singapore Association for Counselling (SAC). The same course delivered in our Australian campus is also accredited by the Australian Counselling Association (ACA).

24 months part-time (Commencing in Trimester)

## 2 subjects (12 credit points)

### Research Pathway

- Research Planning

*\*Admission to Research Pathway is subjected to course coordinator's approval on a case-by-case basis.*

## Advanced Standing

- Students may be granted advanced standing if, in addition to meeting the entry requirements, they can provide evidence of relevant work experience.
- Students may apply for a credit transfer for previous tertiary study or informal and non-formal learning in accordance with the Credit Transfer Procedure. Credit will be granted only for studies completed in the 10 years prior to the commencement of this course.

## Course Requirements

- Each 3 credit point subject requires a minimum of 130 hours of study time per trimester.
- Practicum consists of 110 hours of practice (100 hours minimum face-to-face counselling) over a period of two trimesters.
- Students are supported in sourcing and making arrangements for practicum placements. The University meets the cost of 10 hours of Clinical Supervision support in keeping with ethical codes and requirements.
- This 100 hours of direct Counselling needs to be ethically supported by a minimum of 10 hours of individual Clinical Supervision provided by a SAC Registered Counsellor or a practitioner of equivalent standing.

## Entry Requirements

- Completion of an AQF Level 7 bachelor degree in a cognate discipline. Cognate disciplines include, but are not limited to, career development, community services, education, life coaching, mental health, pastoral care, health, human services, psychology, social sciences, behavioural science, social work, law, or youth work.

## English Requirements

- Completion of an AQF Level 7 bachelor degree in a cognate discipline. Cognate disciplines include, but are not limited to, career development, community services, education, life coaching, mental health, pastoral care, health, human services, psychology, social sciences, behavioural science, social work, law, or youth work; or
- Satisfactory completion of James Cook University Singapore English Language Preparatory Program (ELPP); or
- Completing a course of study delivered in English or experience in an English-speaking workplace may help you demonstrate the English language skills you need at JCU.
