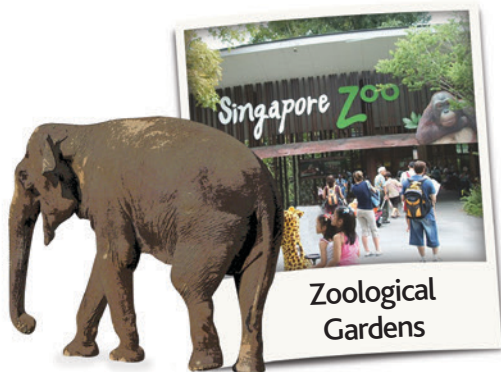

Entry Requirements

Undergraduate - You must have successfully completed 6 months of full-time study at a recognised higher education institution and received a minimum cumulative GPA of 4.0 out of 7.0, or minimum average results of a passing grade.

Gap Year - You may be eligible to apply directly after high school and must provide your High School Certificate (or equivalent).

Postgraduate - You must have successfully completed a bachelor's degree or equivalent from a recognised higher education institution.

English language - Students whose native language is not English must generally demonstrate their proficiency.
